Control Tower Control Behaviors









Example: Establish S3 logging and monitoring

Controls

Preventive Control (Service Control Policy)

Disallow changes to logging configuration for AWS Control Tower created Amazon S3 buckets in log archive

> **Proactive Control** (CloudFormation guard rule)

Require an Amazon S3 bucket to have server access logging configured

> **Detective Control** (powered by AWS Security Hub)

S3 bucket server access logging should be enabled

To meet the control objective, you must activate the dependent controls, along with this control.

This control has an inclusive relationship with one or more controls. To improve security and risk management, activate the inclusive controls, along with this control.




